Hon'ble / Sir / Madam

Regarding your application dated 18.07.2022 & subsequent correspondence with the school and based on school inspection

I Education Officer (Primary) Zilla Parishad Nashik, for a period of three years from 01/04/2022 to 31/03/2025 for class 1st to 8th Little Blossom School, Igatpuri,tal-Igatpuri Dist. Nashik is provisionally approving the school with name and address.

The above approval is subject to fulfillment of the following conditions:-

The period of recognition shall not be extended and there shall be no restriction under any circumstances to grant recognition or affiliation after Class VIII.

- The school shall comply with the provisions of the Children's Free and Compulsory Education Act, 2001 (Appendix One) and the Maharashtra Right of Children to Free and Compulsory Education Rules, 2011 (Appendix Two).
- 2. The school shall admit children belonging to the nearest weaker sections and disadvantaged groups, in the first grade, to the extent of at least 25% of the student population in that grade and shall provide them with free and compulsory education up to primary education provided that this standard shall also be complied with in the case of pre-primary grades.
- For the children specified in clause 3, the school will be reimbursed in accordance with section 12 (2) of the Act, a bank account will be provided to the school for receiving such reimbursement.
- The institution/school shall not charge any capitation fee and shall not compel the child or his or her parent
  or guardian for any screening procedure.
- No child shall be denied admission to school for want of proof of age, religion, caste or race, place of birth or any of these.
- (i) No child admitted to a school shall be retained in that grade or expelled from school until the completion of primary education.
- (ii) No child shall be subjected to corporal punishment or mental torture.
- (iii) No child shall be required to pass the examination of any Board up to Primary Education High.
- (iv) Every child who has completed primary education shall be given the certificate prescribed unterrupted.

(v) Students with disabilities/special needs will be included as per the provisions of the ACNOTED & REGISTERED

(vi) leagher possessing the minimum qualification prescribed under section 23 (1) of the Act shall be appointed. Provided further that the teachers holding the minimum qualification on the date of commencement of the Act shall acquire such minimum qualification within a period of 5 years.

(vii) the teacher shall discharge his/her duties specified in section 24 (1) of the Act, and

(Viii) the soppol shall ensure that the teacher does not engage himself/herself in private tutoring.

- The school is not run for the benefit of any person, group or association of persons or any other person or for making any profit
- 14. The accounts of the school should be audited and certified by a Chartered Accountant and proper accounts should be prepared as per the rules. A copy of each account statement should be sent to the District Education Officer every year.
- Kindly note that the accreditation code received by your school is RTE / IGT/PRT-02, please mention it in any correspondence with this office.
